Every FloodFree product is custom designed to meet site specific requirements and to withstand flood levels nominated by the relevant authorities. AWMA FloodFree products are designed to help mitigate the risk of property damage during a flood. The effectiveness of the product is directly related to the proper installation, operation and maintenance of the product. Failure to properly maintain your product will affect performance and may reduce the overall effectiveness of your flood mitigation system.

AWMA recommends that the owner implement a regular preventative maintenance program in accordance with the supplied Operations and Maintenance Manual.

AWMA recommends that a flood readiness plan be developed, with training performed to ensure the barrier will/can be activated during times of potential flooding. It is also recommended that a trial deployment test be undertaken at least every 6 months to ensure you are prepared in the event of an emergency and that your barrier remains in full working order.

# **Limited Warranty**

This warranty is for the benefit of the original purchaser only.

AWMA warrants this product and components to be free from manufacturing defects for a period being the earlier of 18 months from the date of delivery or 12 months from the date of installation.

If within the term of this warranty, any AWMA FloodFree product or component is found to be defective upon inspection by an authorised AWMA representative, AWMA shall replace or repair, at AWMA's discretion, any part found to be defective.

This warranty is limited to the replacement of the barrier (and/or components) sent to AWMA<sup>1</sup> in accordance with AWMA's standard terms and conditions. AWMA reserves the right to offer similar replacements if product lines have been discontinued or redeveloped. Replacement parts will only be warranted for the remainder of the original warranty period.

AWMA's total liability in respect of this warranty is limited to the repair or replacement of the defective part only. All other liability for any costs, claims, losses, expenses, demands or damages however they arise (including for negligence of AWMA) are excluded including but not limited to loss of profit or for any indirect, special or Consequential Loss which arise out of or in connection with the supply or use of the FloodFree product range and including any costs incurred for refitting by an installer or any third parties whatsoever.
